#### **Flexible Parent Meetings**

Dillard High School 6-12 will provide information about Title I programs in a timely manner, using various methods of communication (parent trainings, marquee, parent link and meetings). Information about Title I programs, academic programs (ASP), state standards and forms of academic assessments will be shared with parents during Open House/Title I Annual Parent Meeting, parent conferences, and any other time a parent requests such information. Information on secondary (e.g. magnet, athletics, etc.), post-secondary (e.g. college/university, vocational, military, etc.) options will be offered to parents through FAFSA and Junior Night. A district appointed translator will be provided at all events in alignment with Dillard's cultural-ethnic make-up (e.g. Hispanic and Haitian) to encourage effective and active participation at Title I events amongst the ELL population. There will also be an ESE/ESOL Night offered by the ESE Specialist, ESOL Contact, and Foreign Language teachers. A "transition night" will be offered through the Title I and College and Career Readiness/Guidance Departments to assist parents and students with course selection, accelerated coursework, vocational training opportunities, and accessing invaluable school resources such as Pinnacle, Naviance, and Khan Academy just to name a few.
